OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinddale Wyo  
February 7, 1961

The Board met on this day in regular session with Commissioners Frank B. Bray, Sr. and Milford Steele and their Clerk H.H. Summers present. The minutes of the previous meeting was approved as read. The reports of the various County Officers were approved and ordered filed, Rebate Order No. 156, Arthur McIntosh, \$7.91 was issued to Arthur McIntosh on 1961 taxes. The following Acceptance Agreements were approved and money ordered turned into the County Treasury: No. 380, Town of Pinedale \$50.00; No. 381, Phillips Petroleum Co., \$12.71. The following Bonds were approved: Alice E. Harrower \$4000.00, Secretary-Treasurer Sublette County Library Board; C.A. Fear, Jr. Secretary-Treasurer Sublette County Fair Board. Having been moved, seconded and carried the following resolution was adopted:

RESOLUTION

WHEREAS, The Board of County Commissioners of Sublette County, Wyoming, have decided to vacate a portion of the Daniel-Hoback Road No. 34, described as follows: Commencing at Station 18, Daniel-Hoback Road No. 34 which is located in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ , Section 34 T35N., R111W of the 6th P.M., Wyoming and running thence west to station 19, thence west to station 20, thence north to station 21, thence north to station 22 which is the N $\frac{1}{4}$  Corner of Section 28, T35N, R111W, 6th P.M. Wyoming, which is the point of termination. WHEREAS, agreements have been secured covering all private lands traversed by the above described road and are now of record in the office of the County Clerk and Ex-Officio Registerer of Deeds of Sublette County, and Notice to Vacate Public Road was published according to Law, Road No. 34 as describe above be and hereby is vacted as public road. Dated this 7th day of February A.D. 1961.
