## OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

June 12, 1961

The Board met in special session on this date with Commissioners Milford Steele and Jake Pfisterer and their clerk H.H. Summers present. Having been advertised and no protests filed a Retail Liquor License No. 68 was granted to Lane and Lois Bybee. Having been moved, seconded and carried the following resolution was adopted:

## RESOLUTION

WHEREAS, The Board of County Commissioners of Sublette County, Wyoming, deem the public interest requires that a road be established to be known as the Big Piney-Calpet road described as follows:

Commencing at a point on the west right-of-way line of Highway 189 Which is N19°20'E, 1326 feet from the southwest corner of Section 17, T.29N., R.111W; thence westerly Through Sections 17 and 18, T.29N. R.111W, Sections 24, 23, 22, 21, 20, 19 and 30, T.29N., R.112W, Sections 25 and 26, T.29N., R.113W, and terminatin at Station 0°00' of the SC-CFM-4282 road at a point S83°-17'W, 2416 feet from the east one-quarter corner of Section 26, T.29N., R.113W.

NOW, THEREFORE, BE IT RESOLVED, that the said Board do hereby initiate the procedure for the establishment of said road, and declare their intention to establish said road by following out the provisions of Article 3, Chapter 48, Wyoming Compiled Statutes, 1945, as ammended, not inconsistent therewith.
