


OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS.

June 2, 1964

The Board met in regular session on this date with all members present.
The minutes of the previous meeting was approved as read.
The reports of the various County Officials were approved and ordered filed.
The following bonds were approved: C.A. Fear, Jr., Treasurer Sublette County Fair Board, \$2000.00; Robert W. Sievers, Clerk and Treasurer Town of Pinedale, \$2000.00; Lillian C. Allen, Treasurer, Sublette County Museum Board. \$1500.00.
Approved that the mill levy assessed on sheep for the control of predatory animals be set at 35 mills for the 1964 assessment year.
Having been advertised and no protests filed a County Retail Beverage Permit No. 170 was granted to Keith E. Anderson and Mary Hill Anderson, Cora Store.
Paul Scherbel was appointed a Trustee of the Sublette County Memorial Hospital for a period of five years.
Paul Hagenstein was appointed a Trustee of the Sublette County Fair Board for a period of five years.
Mrs. Ruth E. Wilson was appointed a Trustee of the Sublette County Library Board for a period of three years.
Bob Thompson was appointed a Trustee of the Sublette County Museum Board for a period of three years.
