

## OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyo  
Sept. 1, 1964

The Board met in regular session on this date with all members present. The minutes of the previous meeting was approved as read. The reports of the various County Officials were approved and ordered filed. Having been advertised and no protests filed Retail Liquor License No. 79 was issued to Paul and Sharon Pearson, Green River Bar, Daniel, Wyo. The following Acceptance Agreements were approved and money ordered turned into the County Treasury; No. 494, Town of Big Piney, \$30.00; No 495, Town of Pinedale, \$50.00; No. 496, Allen Agency, \$14.40; No. 497, Paul and Sharon Pearson, \$400.00. Having been moved, a seconded and carried the following resolution was adopted:

## RESOLUTION

WHEREAS, the Board of County Commissioners of Sublette County, Wyoming, did institute proceedings to vacate a public road described as follows: Commencing at a point on the east line of Section 5, T29N., R111W., 6th P.N. and running thence easterly through Sections 4, 3 and 2, (Three Bridges Road following along the north side of Green River to the crossing) and terminating at a point on the east line of Section 2, T29N., R111W. WHEREAS, agreements have been secured covering all private lands traversed by the above road, the Viewers Report recommending the vacating of the road have been received and filed, Notice to Vacate Road was published according to law, and no protests were filed. NOW THEREFORE BE IT RESOLVED, that the portion of the above described road as described above be and hereby is vacated as a public road.
