The board met in regular session on this date with all members present.
Jake Pfisterer was regularly elected Chairman of the Board for the ensuing two years.
The following bonds were approved: Allen Steel, \$5000.00, Treasurer Sublette County Memorial
Hospital; George A. Wilson \$1000.00, Deputy Sheriff; Elma Kape, \$5000.00, Deputy County
Treasurer; Aune R. Clark, \$2000.00, Deputy County Clerk; Winifred M. Peterson, \$1000.00,
Clerk and Treasurer Town of Big Piney.
The minutes of the previous meeting was approved as read.
The reports of the various County Officers were approved and ordered filed.
Milford Steele was appointed a member of the County Welfare Board for the term of which the
Board of County Commissioners is organized, the ensuing two years.
The Forest Reserve Fund was ordered distributed 80% to Road and Bridge and 20% to Schools.
Pursuant to Chapter 32, Section 406 of the 1945 Compiled Statutes as amended a School Poll
Tax was levied by the Board on every person in Sublette County Between the ages of twenty-
one years and fifty years inclusive in the amount of \$2.00.
On motion regularly moved, seconded and carried the Big Piney Examiner was designated the
Official County Newspapre, for the next two years.
Assessment District were established the same as those establishe January 3 1950 and des-
cribed in the Board minutes of that day in Book 1 of the Commissioners Proceedings at
page 476.
