

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming  
January 4, 1966

The Board met in regular session on this date with all members present.  
The minutes of the previous meeting was approved as read.  
The reports of the various county officials were approved and ordered filed.  
The Forest Reserve Fund was ordered distributed 80% to the Road and Bridge and 20% to Schools.  
Pursuant to Chapter 32, Section 406 fo hte 1945 Compiled Statutes as amended a School Poll Tax was levied by the Board on every person in Sublette County between the ages of twenty-one years and fifty years inclusive in the amount of \$2.00.  
Assessment Districts were established the same as those established January 3, 1950 and described in the Board minutes of that day in Book 1 of the Commissioners Proceedings at page 476.  
The following bonds were approved: Allen Steele, Treasurer Sublette County Memorial Hospital, \$5000.00; Elma Kape, Deputy County Treasurer, \$5000.00; Aune R. Clark, Deputy County Clerk, \$2000.00; William P. Slatter, Under-sheriff, \$1000.00; George A. Wilson, Deputy Sheriff, \$1000.00.

Having been moved, seconded and carried the following resolution was adopted:

RESOLUTION

The Board of County Commissioners will require access on frontage roads for all sub-divisions offered for recordation that would bound or be adjacent to existing or planned arterial roads.
