OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming
July 26, 1966

The Board met in special session on this date with all members present. Being regularly moved, seconded and passed the following resolution was adopted:

APPROPRIATION RESOLUTION

WHEREAS, on the 14th day of June, 1966 H.H. Summers, County Clerk, the budget making authority, prepared and submitted to the Board of county commissioners a county budget for the 1966-1967 fiscal year ending June 30, 1967,

WHEREAS, such a budget was duly entered at large upon the record of this Board and a copy thereof was made available for public inspection at the Office of the County Clerk; and

WHEREAS, notice of a public hearing on such budget, together with the summary of said budget was published in the Big Piney Examiner a legal newspaper published and of general circulation in the county on the 14th day of July, 1966 and

WHEREAS, a public hearing was held on such budget at the time and place specified in said notice, at which time all interested parties were given an opportunity to be heard; and

WHEREAS, following such public hearing certain alterations and revisions were made in such proposed budget, all of which more fully appear in the minutes of the Board.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners that the county budget, as so revised and altered, be adopted as the official county budget for the 1966-1967 fiscal year ending June 30, 1967.

BE IT FURTHER RESOLVED, that the following appropriations be made for the 1966-1967 fiscal year ending June 30, 1967, and that the expenditures of each officer, department or spending agency be limited to the amount herein appropriated.
