Voters will also be given ballots of the following proposed amendments to the Constitution of the State of Wyoming:

Proposed Constitutional Amendment No. 1: would permit the Legislature to establish subordinate courts by General Law.
 Proposed Constitutional Amendment No. 2: would distinguish Congressional District from Districts of the State House of Representatives.
 Proposed Constitutional Amendment No. 3: would repeal the requirement for a state census and allow the State to utilize the Federal Census
 Proposed Constitutional Amendment No. 4: would raise the maximum county mill levy from 12 to 15 mills.
 Proposed Constitutional Amendment No. 5: would provide for a 12 mill replacement levy to help equalize school tax burdens and better distribute school tax revenues on the county level.
 Proposed Constitutional Amendment No. 6: Would authorize the legislature to enact laws providing for the investment of trust funds.
