OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming
December 6, 1966

The Board met in regular session on this date with all members present.
The reports of the various county officers were approved and ordered filed.
The minutes of the previous meeting was approved as read.
The following Acceptance Agreements were approved and money ordered turned into the County Treasury: No. 592, Town of Pinedale, \$50.00; No. 593, Town of Big Piney, \$34.55.
The Bond of Mildred M. Miller as Treasurer of the Big Piney Cemetery District, \$1000.00, was approved.
Robert M. Miller met with the Board.
Reduction Tax Order No. 232 in the amount of \$6.35 was issued to John Frullo on his 1966 taxes.
Mrs. Violet M. Travelute and Miss Mary A. Gillen met with the Board and Hazel Werner, County Assessor, asking that the valuation on their tract of land at the Cora Y be reduced. No reduction was granted at this time but further study will be made on same.
Having been moved, seconded and carried the following Right-of-Way Easement was accepted with reservations:

ACCEPTANCE OF RIGHT-OF-WAY EASEMENT.

Violet M. Travelute and Mary A. Gillen recorded a Right-of-Way Easement which was recorded in Book 24 of Miscellaneous at Page 22 in the County Clerk's office on November 30, 1966, described as follows:

Beginning at a point which bears N 01°17'W, 360 feet and 45°34' W. 427.0 from the $\frac{1}{4}$ corner of Section 27, T.34N., R.110W. of the 6th P.M., Sublette County, Wyoming which is the SE point of the parcel of land; Thence S89°08' W, 974.0 ft to a point, thence N 00°52' W 60.0 ft to a point; thence N 89°08' E, 914.6 ft. to a point, thence S45°34' E, 84.4 ft to the point of beginning of the parcel of land and containing 1.3 acres, more or less.

The Board of County Commissioners of Sublette County, Wyoming, agree to accept this Right-of-Way, but with the following exceptions:

Grantee will not construct any new road.
Grantee will not construct any fences.
