Robert M. MillerA petition was received for the establishment of a County Road from Paul N. Scherbel and others, asking for the establishment of a public road, commencing at a point on the West Right-of-Way line of Highway 189, S88° 11' E, 328.0 ft from the S $\frac{1}{4}$ Corner of Section 17, T.30N., R. 111 W of the 6th Principal Meridian, Wyoming, and running thence N41°29' W 187.5'; N72° 16' W 482.3'; N57°18'W 1608.8'; S57°03'W 528.06' and terminating at a point N67° 14' W, 2215 ft from the S $\frac{1}{2}$ of Section 17, T. 30N., R. 111W. Sublette County, Wyoming. Said Road to be 100 ft wide.

The Commissioners instructed the Clerk to institute proceedings for the establishment of said road.
