June 6, 1967

The Board met in regular session on this date with all members present. The minutes of the previous meeting was approved as read. The reports of the various County Officers were approved and ordered filed. Having been advertised and no protest filed, Malt Beverage Permit No. 220 was issued to James A. Robinson, dba Jim's Coffee Shop, and Liquore Permit No. 86 was issued to Battle Mountain Lodge, and Liquor Permit No. 87 was issued to W.H. Floerke, dba Elkhorn Bar. The following Acceptance Agreements were approved and money ordered turned into the County Treasury. No. 605, Cora Store, \$100.00; No. 606, Kenneth E. Myers, \$100.00; No. 607, Lane E. Bybee, \$400.00; No. 608, Town of Pinedale, \$50.00; No. 609, James A. Robinson, \$100.00. The Board of County Commissioners set July 3, 1967 as their July Meeting date. District Number 4, Water Commissioners John Tiecehart met with the Board of County Commissioners. The Board of County Commissioners ordered the Treasurer to distribute the interest money earned to the various departments. The following bonds were approved: Robert W. Sievers, as Clerk-Treasurer for the Town of Pinedale in the amount of \$2000.00; Lillian Allen as Treasurer for the Museum Board in the amount of \$1500.00. Robert & Helen Evans met with the Board on Insurance matters. Following bills were audited and cash warrants ordered drawn.
