OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

August 1, 1967

The Board met in regular session on this date at 9:30 am with Milford Steele, Chairman Robert M. Miller, board member, Robert W. Evans, County Clerk and Elmer Faler, Supt. of Roads and Bridges present.

The minutes of the previous meeting were approved as read.

A representative of Colonial Life and Accident Co. discussed group accident coverage for employees of the County. The Board of Commissioners gave their consent for the representative to talk to the County employees on this subject.

Effective August 1, 1967, the Sublette County Commissioners appointed Richard F. (Dick) Tanner County Coroner to fill the vacancy caused by the death of F.W. Tanner.

Glenn Wise, Bill Bayer and Jim Wells met with the Board for approval of County Roads to the Riverside subdivision and the power plant.
