





OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyo.
September 5, 1967

The Board met in regular session on this date at 9:00 AM with Milford Steele, Chairman, Robert Miller, member, Jake Pfisterer, member, Elmer Faler, Road & Bridge Supt. and Robert W. Evans, County Clerk, present.

The minutes of the previous meeting were approved as read.

The monthly reports of the following County Officials were approved and ordered filed: Hazel Bloom, Clerk of Court; Dolores Daniels, Justice of Peace; and Robert W. Evans, County Clerk.

The appointment of Penny Wilder as Deputy County Clerk effective Sept. 1, 1967 was approved by the Board.

The following bonds were approved and ordered filed: Penny Wilder, Deputy County Clerk, \$2,000.00; Richard F. Tanner, County Coroner, \$1,000.00; Sandra Carr, Clerk and Treasurer for the Town of Marbleton, \$1,000.00; Walden L. Campbell, Treasurer School District No. 5, \$2,000.00; and Harold Faler, Treasurer School District No. 1, \$20,000.00.

The following Acceptance Agreements were approved and money ordered turned into the County Treasury: No. 624, Bill Bloom, \$10.00; No. 625, Sublette Co. Sporting Assoc., \$10.00; No. 626, Sublette Co. Roping Club, \$10.00; No. 627, Bob Penton, \$10.00.

Massey Ferguson, Inc. made formal application to the Board for a hearing at any of its special or general meetings on taxes paid by Massey Ferguson, Inc. under protest on behalf of Westside Implement Co. and R. J. Tamblyn. John Mackey, County Attorney, and Donald W. Sparks, County Treasurer, met with the Board to discuss the matter and set a date for the hearing. The Board agreed to hold the hearing at their regular meeting Oct. 3, 1967 at 2:00 PM.

Albert Miller appeared before the Board to request the use of a patrol in laying an asphalt road one thousand feet in length in the Bloom Subdivison. The Board agreed to furnish a patrol at the convenience of the Road and Bridge Dept. to assist Mr. Miller in laying the road, but excluding the approach from the highway.
