

OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming
November 7, 1967

The Board met in regular session this date at 9:00 A.M. with Milford Steele, Chairman, Jake Pfisterer, member, Elmer Faler, Road & Bridge Supt., and Robert W. Evans, clerk, present.

Minutes of the Oct. 3, 1967 meeting were read and approved.

The monthly reports of the following county officials were approved and ordered filed in the County Clerk's office: Hazel Bloom, Clerk of Court, Dolores Daniels, Justice of the Peace, Big Piney, Paul Ziegler, Justice of the Peace, Pinedale, and Robert W. Evans, County Clerk.

The Board gave its approval for the Museum Board to place a bronze or brass plaque in memory of James Harrower in the Sublette County Court House.

Morris Horton, Sheriff of Sublette County met with the Board and requested that new lights be installed in the various county offices and that fire doors be installed in the Court House. The Board granted him permission to have this work done.

Mr. Alfred V. DeBernardi, District Engineer and Don Diller, District Construction Engineer, met with the Board and requested that the County Commissioners write a letter requesting three and one quarter miles extension to the proposed secondary road north of Cora. They also informed the Board that they were going to have to complete their contract on the abandoned highway thirty-five miles south of Pinedale and requested the county to remove the three bridges and the various culverts. The County agreed to remove the bridges and culverts for salvage.

Mrs. Ruth Wilson, member Sublette County Library Board, met with the Board and explained that the Library Board was unable to obtain Federal money this year and therefore wanted to place their county money on time deposit until such time Federal money was available.

Mrs. Helen Evans met with the Board and requested the Board to assign the County's Certificate of Purchase on Lots 7, 8 and 9, Block 12, Town of Boulder, Wyoming to her. The Board decided to wait until their next regular meeting before making the assignment.

The Board examined the State Examiner's report on examination of Sublette County offices as of the close of business, Sept. 26, 1967 and replied as follows: "We, the undersigned, constituting a quorum of the Sublette County Commissioners, of Sublette County, Wyoming acknowledge receipt of the Report on Examination as above noted, made under the supervision of your Department.

After careful consideration of this report, we concur with the Examiner in the suggestions he has made and we have requested the officials to adjust their methods in compliance therewith, to-wit: 1. The First National Bank of Pinedale has delivered the Joint Custody Receipt covering the tri-party escrow agreement between the First National Bank and the Colorado depositories for the securities to the County Treasurer. 2. In the future, all bad checks will be turned over to the County Attorney immediately for collection.

A copy of this acknowledgment has been placed of record with the minutes of our meeting on November 7, 1967. /s/ Milford Steele and Jake Pfisterer."
