OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

December 5, 1967

The Board met in regular session this date at 9:00 A.M. with Milford Steele, Chairman, Jake Pfisterer, member, Robert Miller, member, Elmer Falter, Road and Bridge Supt. and Robert W. Evans, County Clerk, present.

Minutes of the Nov. 7, 1967 meeting were read and approved.

The monthly reports of the following county officials were approved and ordered filed in the County Clerk's office: Hazel Bloom, Clerk of Court; Dolores Daniels, Justice of the Peace, Big Piney; Paul Ziegler, Justice of the Peace, Pinedale; and Robert W. Evans, County Clerk.

The following Acceptance Agreements were approved and the money ordered turned into the County Treasury: No. 629, Robert W. Sievers, \$185.00; No. 630, Lillian C. Allen, \$50.00; No. 631, Town of Pinedale, \$200.00.

The following bonds were approved by the board and ordered filed with the County Treasurer. Mildred M. Miller, Treasurer Big Piney Cemetery District, \$1,000.00; Allen Steele, Treasurer Sublette County Memorial Hospital Board, \$5,000.00.

The Petition and Affidavit for Abatement of Double Assessment and Erroneous Taxes of Joe and Stella Retel was approved by the board and ordered filed with the County Clerk.

Helen Evans addressed the board and again requested an assignment by the board of the County's Certificate of Purchase on Lots 7, 8 and 9, Block 12, Town of Boulder, Wyoming. Upon receipt of \$80.60 the board assigned their Certificate of Purchase on this property to Helen Evans.

Ken Myers met with the board on the possibility of obtaining a liquor license for the Hoback Motel. The board instructed John Mackey, County Attorney, to determine the number of county liquor licenses the county is allowed. Mr. Mackey informed the Commissioners that at the present time only three licenses could be issued. Mr. Myers was then informed of this fact.

Ed Finnegan met with the board to ask the county for help in keeping his road open this winter. The board agreed to plow his road depending on the availability of county equipment.

Dick Wilson met with the board and inquired about an Abstract of Title for a Warranty Deed between Fred and Erma Shriver, grantors, and Dick and Nan Wilson and William L. and Grace Anderson, grantees. The board authorized him to go ahead and have the Abstracts of Title made and then send the bill for this work to the county.

John Mackey addressed the board and brought the commissioners up-to-date on recent happenings and findings of the County Attorney's office relative to Massey-Fergusons request for refund of taxes paid under protest by Massey-Ferguson on behalf of Westside Implement.

Bud Hall, Wortham Machinery representative, met with the board and suggested that the county trade their 1960 Model 99E motor grader for a 1968 Model 120 motor grader. Motion was made by Jake Pfisterer and seconded by Robert Miller to buy the new Caterpillar Model 120 motor grader.

Elmer Falter, Road and Bridge Supt., requested the board to buy another pickup for the Road and Bridge crew. The board agreed to call for bids from local dealers on a 1968 4 x 4 $\frac{1}{2}$ ton pickup. Paul Hagenstein addressed the board to inform them that Felix Rilinger would sell the county ten acres of land for a gravel pit and future building site. The asking price for this land was \$550.00 per acre. The county agreed to buy the land and to furnish Felix with a legal description of the land purchased.

The board made the following appointments to the Sublette County Planning Board, Paul N. Scherbel, Big Piney, John Kvnenhild, Big Piney, Harvey Taylor, Pinedale, Norman Pape, Daniel and Hank Snow, Pinedale. The Planning Board will hold their organizational meeting Dec. 15, 1967 at seven P.M. in the court room of the Sublette County Courthouse.
