It was agreed by the board that a sixty day postponement of any action on the proposed zoning resolutions would be granted to the citizens of Sublette County so that they may submit proposed changes in writing to the planning and zoning commission for their consideration and approval.

Bill Isaacs, chairman of the citizens committee, set a meeting date of May 13, 1968 for all interested persons to discuss Chapter 3, definitions and the section on mobile homes and trailers. It is hoped by Mr. Isaacs that the necessary changes wanted by the citizens can be drawn up in written form and presented to the commission shortly after this meeting. The second meeting date was set for Big Piney, May 27, 1968.

It was felt by the board that the participation by the citizenry of Sublette County would ease the load on both the planning and zoning commission as well as the county commissioners and that they would welcome the suggested changes for consideration.

It was moved and seconded that this hearing be continued at a later date.

OFFICIAL COUNTY COMMISSIONER'S PROCEEDINGSPinedale, Wyoming
May 7, 1968

The board met in regular session on this date at 9:00 A.M. with Milford Steele, chairman, Robert M. Miller, member, Jake Pfisterer, member, Elmer Faler, Road and Bridge Supt. and Robert W. Evans, clerk, present

Minutes of the previous meeting were approved as read.

The monthly reports of the following county officials were approved and ordered filed with the county clerk: Hazel Bloom, Clerk of Court; Dolores Daniels, Justice of the Peace, Big Piney; Paul Ziegler, Justice of the Peace, Pinedale; Robert W. Evans, County Clerk.

It was moved and seconded by the board to delay action on the zoning resolutions for a period of sixty days in order for the citizens of Sublette County to recommend in writing changes to the Planning and Zoning Commission.

There being no protests offered on the proposed increase of county liquor license fees, the board moved and seconded that the county liquor license fee would be increased from four hundred dollars to five hundred dollars per year.

Paul N. Scherbel, presented the board with the official plat of the Peck Addition to the Town of Big Piney. The board approved the plat as presented.

Larry Lozier, Donna Krause, Richard Hecox, Margie Buyer, Mr. and Mrs. David Shannon met with the board relative to the status of the state secondary road north of Cora. They were informed by the board that they had received from the State Highway Dept. their specifications and recommendations and that a representative of the State Highway Dept. would meet with the board the week of May 13th and at that time would try to get easements for this road signed by the Bar Cross Land and Livestock Co.

Carroll Noble met with the board to request that the county put a cattle guard and culvert in to a forty acre tract of land in the Miller Lane to be used as a recreational area. Mr. Noble explained that this forty acre tract would be developed with picnic tables and recreational facilities by the Sublette Wildlife Federation. The board agreed to install the cattle guard, but they felt that the culvert would not be needed.
