OFFICIAL COUNTY COMMISSIONER'S PROCEEDINGS

Pinedale, Wyoming
June 4, 1968

The Board met in regular session on this date at nine A.M. with Milford Steele, chairman, Robert M. Miller, member, Jake Pfisterer, member, Elmer Faler, Road and Bridge Supt. and Robert W. Evans, clerk, present.

The minutes of the previous meeting were approved as read.

The monthly reports of the following county officials were approved and ordered filed with the county clerk: Hazel Bloom, clerk of court; Dolores Daniels, justice of the peace, Big Piney, Paul Ziegler, justice of the peace, Pinedale; and Robert W. Evans, county clerk.

The following Acceptance Agreements were approved and the money ordered turned into the county treasury: No. 636, Town of Pinedale, \$150.00; No. 637, Sublette County Sporting Association, \$10.00; No. 638, Kenneth and Betty Myers, \$100.00.

The following bond was approved and ordered filed with the county treasurer, Robert W. Sievers, clerk and treasurer, Town of Pinedale, \$2,000.00.

Col. Eastmond submitted to the board a road petition for obtaining a county road across the NW $\frac{1}{4}$ NW $\frac{1}{4}$ and SW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 2, T33N, R109W, 6th P.M. The description of the right of way is as follows:

Commencing at the termination of the County road at the NW corner of Section 2, T33N, R109W. of the 6th P.M., Wyoming and running thence Southeasterly and South to a point 165 feet East of W $\frac{1}{4}$ corner of Section 2, thence South to the North boundary of the Bakes Subdivision and connecting with Bakes Lane, thence Southeasterly along Bakes Lane to the County road along the South Boundary of the NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 2, T33N, R109W and being approximately 3/4 miles in length and following in general the route of the present unimproved access roads, and terminating at approximately 600 feet of SW corner of the NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 2, T33N, R109W., 6th P.M., Wyoming. Phil Marincic, Jr. was appointed as viewer for the proposed road.

Jim Noble met with the board relative to signing right-of-way easements for the North Cora road. The board was unable to fulfill Mr. Noble's request.

The board met with Mr. Hugh Wall, District Manager of the B.L.M. office and requested that B.L.M. apply for the installation of a culvert on the North Cora road on present B.L.M. land which might be used for possible future irrigation.
