Bill Isaacs and John Mackey met with the Board and discussed the zoning resolution the Citizens Committee had developed. After some discussion it was moved by Commissioner Miller and seconded by Commissioner Pfisterer, motion carried, that the Zoning Resolutions certified to the Sublette County Board of Commissioners be rejected and recommended that the Citizens Committee present their resolution to the Planning and Zoning Commission for their consideration and approval. John Kvenild, chairman of the Planning and Zoning Commission, set Aug. 16, 1968 as the date for a public hearing on the new zoning resolution.

Bill Isaacs met with the board relative to the establishing a one half county mil levy to be used for establishing and developing county recreation.

The board considered the report submitted by Phil Marincic, Jr., road viewer for the petition presented at the June 4, 1968 board meeting. It was moved by Commissioner Pfisterer and seconded by Commissioner Miller, motion carried that the board respect the opinion of the viewer to postpone any action on said road until such time that more people moved into the area and possibly a greater need for said road developed. At this time the viewer felt that the road would be too expensive to build.

Bids on a 1969 car for the sheriff's department were opened by the board. The board accepted the low bid of \$2,600.00 of Worl's Ford Service.

The Board of Commissioners approved a thirty-five mil levy on sheep for the control of predatory animals for the 1968 assessment year.

The board examined the State Examiner's report on examination of Sublette County offices as of the close of business, April 30, 1968 and replied as follows: "We, the undersigned, constituting a quorum of the Sublette County Commissioners of Sublette County, Wyoming acknowledge receipt of the Report on Examination as above noted, made under the supervision of your Department. After careful consideration of this report, we concur with the Examiner in the suggestions he has made and we have requested the officials to adjust their methods in compliance therewith, to-wit: 1) That money deposited in the bank be made in accordance with Sections 9-604 & 9-606, Wyoming Statutes, 1957 which require that funds deposited in other than demand accounts must be in the form of "Time Deposit-Open Accounts"; 2) That joint custody trust receipts should be furnished by the depositary bank according to the form set forth in Sections 9-616, Wyo. Statutes, 1957. 3) Current year's county fees should be distributed on the current year's percentage chart. 4) All vouchers for travel expenses will be required to have properly itemized and signed receipts attached for such items as meals, rooms, etc. A copy of this acknowledgment has been placed of record with the minutes of our meeting on July 2, 1968. Mary Bakes, Dr. Johnston, Mrs. Johnston and Mrs. Monte Skinner met with the board relative to the aforesaid road petition.

Paul N. Scherbel presented the board with the official plat of Block 3, Cooley First Addition to the Town of Pinedale. It was moved by Commissioner Pfisterer and seconded by Commissioner Miller, motion carried, that the official plat as presented be approved by the board. It was moved by Commissioner Miller and seconded by Commissioner Pfisterer, motion carried, that the following appointments be made to the various County Boards: Ed. Moore, 5 year term, Hospital Board; Harry Lovatt, 3 year term, Museum Board; Max Boroff, 5 year term, Fair Board; Jack Kerback, 3 year term, Library Board.
