OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming
December 9, 1968

The Board met in regular session on this date, at 9:00 A.M., with Milford Steele, Chairman; Robert M. Miller, member; Jake Pfisterer, member; Elmer Faler, Road and Bridge Superintendent and Robert W. Evans, clerk, present.

The minutes of the previous meeting were approved as read.

The monthly reports of the following County Officials were approved and ordered filed with the County Clerk: Hazel Bloom, Clerk of Court; Dolores Daniels, Justice of the Peace, Big Piney; Paul Ziegler, Justice of the Peace, Pinedale; and Robert W. Evans, County Clerk.

The following bonds were approved and ordered filed with the County Treasurer: Mil-dred M. Miller, Treasurer, Big Piney Cemetary District, one thousand dollars (\$1,000.); Allen Steele, Treasurer, Memorial Hospital of Sublette County, five thousand dollars (\$5,000.).

Motion made by Commissioner Pfisterer, Seconded by Commissioner Miller, motion carried, that the following road resolution be adopted:

RESOLUTION

WHEREAS, The Board of County Commissioners of Sublette County, Wyoming, deem the public interest requires that a road be established to be known as the Green River Stock Drive-way County Road, Project Number 23-107, described as follows:

Beginning at a point s89°-19'W, 431 feet from the southeast corner of Section 16, T34N, R110W, Sublette County, Wyoming;
thence Northerly, along the easterly line of said Section 16 to the Northeast corner;
thence Easterly, along the south line of the SW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 10 to the westerly right-of-way line of State Secondary Highway No. 1802;
thence Northerly parallel to and alongside of the westerly right-of-way line of said highway and extension through the NW $\frac{1}{4}$ SE $\frac{1}{4}$ and S $\frac{1}{2}$ NW $\frac{1}{4}$ of Section 10; NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 4, T34N, R110W, and the E $\frac{1}{2}$ SW $\frac{1}{4}$ of Section 33, T35N, R110W to a terminus at the center one-quarter of said Section 33.
