

Official County Commissioners proceedings, continued

Pinedale, Wyoming
January 7, 1969

The bonds of the following Deputy County Officers, having been approved, and the said persons having prescribed to the required oath of their respective offices, were on motion, duly made and carried, declared qualified and appointed: Lois J. Yake, Deputy County Clerk, two thousand dollars (\$2,000.); William P. Slatter, Undersheriff, one thousand dollars (\$1,000.); George A. Wilson, Deputy Sheriff and Jailer, one thousand dollars (\$1,000.); and Elma Kape, Deputy County Treasurer, five thousand dollars (\$5,000.).

The following bond was approved and ordered filed with the County Treasurer: Ross Calvert, Treasurer, Sublette County Fair Board, two thousand dollars (\$2,000.).

Under motion, duly made and carried, the Forest Reserve Fund was ordered distributed eighty per cent to Road and Bridge and twenty per cent to schools.

Under motion, duly made and carried, Paul N. Scherbel was appointed County Surveyor for the next two ensuing years.

Richard Hecox, Dorothy Hecox, Paul N. Scherbel, Lillian Allen and John Mackey, Sublette County Attorney, met with the Board to consider the Hecox Second Addition Sub-division plat. The following change was recommended to Mr. Hecox, by the Board; restriction on the number of access roads, from the sub-division to the county road, should be included on the sub-division plat. He will present the plat and the covenants and restrictions to the Board for their approval at the February 1969 meeting. Mr. Mackey, County Attorney, informed the Board that any sub-division plat, within the incorporated limits of the municipalities, does not need to be approved by the county commissioners, also any sub-division plat, within one mile of the incorporated limits of the municipalities, must be jointly approved by the county commissioners and the governing body of the municipality. For sub-divisions located greater than one mile from the incorporated limits, or in any other part of the county, the sub-division plat must be approved by the county commissioners.

Vernon Delgado and Harvey Taylor met with the Board to discuss the possibility of the Sublette County Courthouse being supplied with natural gas service when the service is installed in the town of Pinedale. They requested that the Board sign an agreement for this service. The Board instructed their clerk to request that the commissioners be furnished a price estimate on these services. The Board felt that they needed some time, to study these estimates and compare them with the present cost, before they were willing to sign this agreement.

It was moved by Commissioner Miller, seconded by Commissioner Pfisterer, motion carried, that the Board of County Commissioners call for sealed bids on the construction of a 60'x170' insulated metal shop building to be built on the NE $\frac{1}{4}$ SE $\frac{1}{4}$ of Sec. 23, T33, R109, 6th P.M., Wyoming. All bids will be opened at 2:00 P.M. March 4, 1969, at the regular County Commissioners meeting, in the Commissioners room of the Sublette County Courthouse. Any contractor interested in submitting a bid, on this building, can obtain copies of the building floor-plan and specifications at the Clerk's office, Sublette County, Wyoming. The Board reserves the right to reject any or all bids.

The Planning and Zoning Commission submitted the name of Milford Steele for appointment to the commission. This appointment is to replace John Knevild, whose term expired in December 1968. Milford Steele declined the appointment. The Board then asked Commissioner Miller to submit a name of a person, living in the Big Piney area, to fill the vacancy. The Board inquired of John Mackey as to the status of the present zoning resolution to be submitted to the Planning and Zoning Commission by the Citizens Committee. Mr. Mackey informed the Board that nothing was presently being done and no resolution is ready to be submitted at this time.

Don Jewitt, State Senator, met with the Board to discuss various legislation to be presented to the Legislature during the upcoming session. There were various bills that the Board felt should be passed and they felt that some statutes should be clarified.

Charles Sims and Paul Scherbel met with the Board to discuss the possibility of purchasing a communication system for the Big Piney fire trucks. Mr. Sims presented a proposal, from the General Electric Company, for a communication system, adequate for their use in the Big Piney fire trucks, for a cost of approximately forty-two hundred dollars (\$4,200.). The Board requested that Mr. Sims have a representative from the Motorola Company make a study of a proposed county-wide communication system, and then make a report of the findings to the Board at the regular meeting, February 4, 1969. This county-wide communication system could be used by the county Road and Bridge Dept., the Big Piney Fire Dept. and the Pinedale Fire Dept., if they so choose.

The Board decided that a check of all county roads for necessary easements, plats and resolutions was necessary at this time and instructed the County Clerk's office to proceed along these lines. At the completion of this work there will be two card files giving the present status of each road in the county. These card files will be located at the County Shop office and the County Clerk's office.
