

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming
March 4, 1969

The Board met in regular session, on this date, at 9:00 A.M. with Jake Pfisterer, chairman; Robert M. Miller, member; Paul C. Hagenstein, member; Elmer Faler, Road and Bridge Superintendent, and Robert W. Evans, County Clerk present.

The minutes of the February 4, 1969 meeting were approved as read.

The monthly reports of the following County Officials were approved and ordered filed with the County Clerk: Hazel Bloom, Clerk of Court; Dolores Daniels, Justice of the Peace, Big Piney; Paul Ziegler, Justice of the Peace, Pinedale; and Robert W. Evans, County Clerk.

Motion, duly made, by Commissioner Hagenstein, seconded by Commissioner Miller, motion carried, that the following road resolution be adopted:

RESOLUTION

WHEREAS, the Board of County Commssioners of Sublette County, Wyoming, deem the public interest requires that a road be established to be known as the South Bench Road No. 23-109 described as follows:

Beginning at the point where the South Line of the North half of Section 23, T33N, R109W. intersects the Easterly right of way line of U.S. Highway No. 187,
thence Easterly through the SE $\frac{1}{4}$ NW $\frac{1}{2}$ and NE $\frac{1}{4}$ SW $\frac{1}{2}$ of Section 23
thence Easterly through the S $\frac{1}{2}$ N $\frac{1}{2}$ and N $\frac{1}{2}$ S $\frac{1}{2}$ of Section 24
thence Easterly through the S $\frac{1}{2}$ NW $\frac{1}{4}$ and N $\frac{1}{2}$ SW $\frac{1}{4}$ of Section 19

WHEREAS, right of way easements have been secured from Marjorie Hagenstein, J. W. Brazzill, Thomas Coats, et ux, George E. Fowler, et ux, Felix Rilinger, George M. Austin, et ux, E. R. Cody, et ux, and Robert Walker as owners of the only patented lands.

NOW, THEREFORE, BE IT RESOLVED, that the South Bench Road No. 23-109, as described above, be and it hereby is declared established as a public road.

Gene Inloes met with the Board to inform them that he would be leaving Sublette County, as of May 1, 1969. Mr. Inloes informed the Board that he would be going to Wells County, Colorado.

Robert J. Hoggan, representative of Motorola Corp., met with the Board to discuss the present status of the county-wide communication system. The Board informed Mr. Hoggan that to date they hadn't received a reply, from the Wyoming Highway Department, on the possibility of the county road and bridge department and the two fire departments using the Highway Maintenance Communication system, and that the Board would not consider another communication system until definite word had been received from the Wyoming Highway Department.

John Mackey, Sublette County Attorney, met with the Board to discuss the status of the petition filed, in District Court, on the August 20th Bond Election. The Board requested that Mr. Mackey file a motion, in District Court, for dismissal of the petition, and let the Court make a ruling on his motion. Mr. Mackey also informed the Commissioners, that Massey-Ferguson was ready to commence their suit for the rebatement of taxes that they had paid on behalf of Robert Tamblin. The Board also inquired, of Mr. Mackey, the status of the Citizens Planning and Zoning Resolution. Mr. Mackey informed the Board that they were waiting for the return of Mr. Bill Issacs before any work could be done on the Citizens Planning and Zoning Resolution.

The Board considered and accepted the resignation of Harold Snow, from the Planning and Zoning Commission. On motion, duly made, by Commissioner Miller, seconded by Commissioner Hagenstein, motion carried, that Monte Skinner be appointed to fulfill the unexpired term of Harold Snow to the Planning and Zoning Commission. This term expires June 30, 1970.
