OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming
May 9, 1969

The Board met in Special Session, this date, at 1:30 P.M. in the courtroom of the Sublette County Courthouse, with Jake Pfisterer, Chairman; Robert M. Miller, Member; Paul C. Hagenstein, Member; Elmer Faler, Road and Bridge Supt.; and Robert W. Evans, Clerk, present. Also present were Bureau of Land Management representatives, Dave Crumb, John Benson and Ray Jorgensen; and U. S. Forest Service (Bridger National Forest) representatives, Don Housley, Glen Osborn and Bruce McCurtain; and Wyoming Game and Fish representatives, Darwin Creek, Bob Jackson, Jim Straley, Ron Williams and Kay Bowles.

The purpose of the meeting was to determine what roads, within Sublette County, should be public roads. It was explained to the group that, in order to establish a county road, the following three conditions must be met:

1. Easements must be obtained for all lands that are either privately owned or State owned upon which the road traverses. And an affidavit and plat of the road on all government lands must be filed with the State Director, Bureau of Land Management, Cheyenne, Wyoming, and an affidavit recorded in the County Clerk's office.
2. All roads must have a linen filed in the County Clerk's office.
3. A resolution by the County Commissioners, declaring the road as a county road, must be prepared and recorded in the County Clerk's office.

Each agency was then called upon to express their needs for the different road requirements of their agency. It was agreed by all agencies present, that all roads designated would be cateforized as county roads, and would therefore appear on record in the Sublette County Clerk's office.

Each road was given a name and number and placed upon the official list of county roads.

Attached is a list of roads and the agency or agencies who have taken the responsibility of obtaining a description for the necessary easements. In some cases easements have been granted. The agency will also be responsible for filing the plat of the road in the County Clerk's office. The Board agreed that the county would prepare the necessary easements from the descriptions furnished and declare the road a county road by resolution.

Also attached is a complete list of all proposed county roads. It is the immediate objective of the Board to get all roads officially established as county roads.

It was suggested and agreed upon that the agencies involved would meet once a year (preferably in January) to review the status of the various roads of Sublette County.
