

Official County Commissioners Proceedings, continued

Pinedale, Wyoming
February 3, 1970

Rob Lozier and Phil Marincic met with the Board on a road petition submitted, to the Board, by Leo Jensen. It was the viewer's recommendation that a sixty foot right-of-way easement be granted and recorded from the Secondary Highway to Leo Jensen's property line. Mr. Lozier said that he would be willing to sign an easement for this road providing Mr. Jensen would sign the easement through his land on the Boulder-North Road. The Board agreed to delay any action on this proposed road until the next regular meeting, March 3, 1970.

Robert Seaton met with the Board to discuss Public Law 95-83, concerning a program for the control of noxious plants on federally-owned land.

Robert Seaton and Phil Marincic met with the Board to discuss the next years budget of the Fair Board. Phil explained that the Fair Board anticipated on budgeting approximately \$8,000.00 next year to build an addition to the cattle barn at the fair grounds.

On motion by Paul Hagenstein, seconded by Robert Miller, motion carried, that the following resolution be adopted:

RESOLUTION NUMBER 69-100

A resolution providing for an organization (Wyoming Statutes, Chapter 5, Section 19-107, 1951 as amended) of an Emergency or Disaster Council for Civil Defense and Emergency Planning to plan for and assist in the survival of persons and the protection of property within Sublette County and the Incorporated Communities of Pinedale, Big Piney and Marbleton, Wyoming, in the event of an emergency or disaster; providing for coordination with other public agencies, corporations and private persons; defining the word "disaster"; providing for an emergency administrator or coordinator and enrollment of assistants, and defining their powers and duties; requiring public cooperation with, and obedience to, the orders of such organization.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SUBLETTE COUNTY, WYOMING, AND THE INCORPORATED COMMUNITIES OF PINEDALE, BIG PINEY AND MARBLETON, WYOMING:

SECTION 1: There is hereby created within Sublette County, and the Incorporated Communities of Pinedale, Big Piney and Marbleton, Wyoming, with jurisdiction throughout said County and Incorporated Communities, an organization to provide for the coordination of the emergency and civil defense functions of said County and Incorporated Communities and all other public agencies and affected private persons, corporations, and organizations. Upon declaration of an emergency by the local government any expenditures made in connection with such disaster activities and civil defense, including mutual aid activities, for the direct protection and benefit of the inhabitants and property of Sublette County and the Incorporated Communities of Pinedale, Big Piney and Marbleton, Wyoming.

SECTION 2: Definitions:

A. Emergency Planning and Civil Defense. As used in this resolution the term "Emergency Planning and Civil Defense" shall mean the preparation for and the carrying out of all emergency functions for which military forces are primarily responsible.

B. Disaster. As used in this resolution, the term "Disaster" shall mean actual or threatened enemy attack, extraordinary fire, flood, storm, epidemic, earthquake, civil disturbance or other emergency of significant magnitude.

SECTION 3: Membership:

The Sublette County/Incorporated Communities of Pinedale, Big Piney, and Marbleton Emergency or Disaster Council for Civil Defense and Emergency Planning, hereafter referred to as The Council, is hereby created and shall consist of the Board of County Commissioners of Sublette County and the Mayors of the named Incorporated Communities within said county. The Chairman of the Board of County Commissioners shall be the Chairman, and the Council shall elect one of its members Vice Chairman.

SECTION 4: Powers and Duties:

It shall be the duty of the Council, and it is hereby empowered to prepare, review and recommend for adoption, the Local Emergency Operations Plan (LEOP), mutual aid plans, agreements and such resolutions and rules and regulations as are necessary to implement such plans and agreements. The Council shall meet monthly and upon call of the Chairman, or in his absence, the Vice Chairman. It is agreed that the primary responsibility for actions at the time of an emergency or disaster rests with the government of the local area affected. Requests for outside assistance can be made only by an authorized official of the government involved as written in the LEOP.
