

Official County Commissioners Proceeding, continued

They also requested that the Board sign a memorandum agreement between the Wyoming Highway Department and the Board of County Commissioners. The Board signed this memorandum agreement. Also discussed was the county plans on where they intended to spend their Federal Aid to Secondary and SC CFM Funds that are now available for building roads. The Board asked Mr. Walters to send traffic-counts on the Green River Lake and Merna Roads (if the Department has these statistics available). It was determined that the amount of funds that will be available by the end of 1970 would be around one-half million dollars. Mr. Walters urged the Board to decide where they wanted to spend this money and then to notify the Wyoming Highway Department so that they could schedule these contracts in their future plans.

Pursuant to Chapter 165, of the 1967 Session Laws, the following dates were approved by the Board of County Commissioners, Sublette County, Wyoming, as special Sunday dates when all licensees may operate without restriction as to closing hours, To-wit: July 5th, July 12th, August 16th and September 6th, 1970.

John Mackey met with the Board in regards to the Bert Feuz petition to combine a part of School District #5, in Sublette County, with School Districts #1 and the Jackson-Wilson High School District in Teton County. This petition was approved by the Boundary Board at the last regular meeting of the Board of County Commissioners.

Motion by Robert Miller, seconded by Paul Hagenstein, motion carried, that the Board appoint Art Kittel and Max Boroff to three-year terms on the Sublette County Welfare Board. These terms would be from January 1, 1970 through December 31, 1972.

The Board discussed the possibility of buying five voting machines, for Sublette County, for the 1970 election. No decision was made on the purchase of these machines.

Hazel Werner and Don Sparks met with the Board and requested that the Board get an estimate as to the cost of remodeling the old Supt. of Schools office into an office for the County Assessor. It was pointed out to the Board that it would be necessary to install, in this office, a 6'x11½' concrete vault. The Board instructed their clerk to contact John Bancroft and get an estimate for this work.

Jake Pfisterer made a report, to the Board, on a meeting held in Jackson on the proposed 2,000 mile hiking trail, along the Continental Divide, from Mexico to Canada. The Board thought that it should get more information before either condoning or opposing the proposed trail. It was stated by Commissioner Miller that he was opposed to any condemnation of public land for the acquisition of this Continental Divide Trail.

Paul Scherbel, Sublette County Suveyor and Mayor of the Town of Big Piney, met with the Board and requested that the county write a letter of recommendation to the Wyoming Highway Department for the approval of a license to build, construct and maintain a walk-way for the children of the Big Piney school system, between the Big Piney High School and the Miller Addition to the Town of Big Piney, and also requested that a ten foot wide by three foot deep bed of gravel was necessary for the walk-way. The Board decided to contact Mr. Kittel, Supt. of the Big Piney School, before agreeing to haul the gravel necessary to construct the walk-way.
