RESOLUTION

WHEREAS, the Board of County Commissioners of Sublette County, Wyoming, deem the public interest requires that a road be established to be known as the Chapel Road No.23-137 described as follows:

Commencing at station 1 on the north right-of-way line of State Secondary 1801, N81°-43'E, 2021.6 feet from the SW corner of Lot 2, Section 18, T30N, R110W.

Thence running northerly through the following:

Section 5 - Lot 2, SW $\frac{1}{4}$ NE $\frac{1}{4}$ , SE $\frac{1}{4}$ NW $\frac{1}{4}$ , E $\frac{1}{2}$ SW $\frac{1}{4}$ , SW $\frac{1}{4}$ SW $\frac{1}{4}$   
Section 7 - SE $\frac{1}{4}$ NE $\frac{1}{4}$ , E $\frac{1}{2}$ SE $\frac{1}{4}$ , SW $\frac{1}{4}$ SE $\frac{1}{4}$   
Section 8 - W $\frac{1}{2}$ NW $\frac{1}{4}$

And terminating at station 11 in the NE $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 33, T31N, R110W, S87°-14'E, 2482 feet from the NW corner of the NW $\frac{1}{4}$  of Section 33, T31N, R110W.

WHEREAS, there are no patented lands.

WHEREAS, affidavits for right-of-ways have been filed and granted by the Land Office in Cheyenne for all Federally owned lands.

NOW, THEREFORE, BE IT RESOLVED, that the Chapel Road No23-137 as described above, be and it hereby is declared established as a public road.
