Commencing at station 350+22.8 on the east right-of-way line of U.S.Highway 189 in the  $SE\frac{1}{4}NE\frac{1}{4}$  of Section 21, T32N, R111W, S06°-47'E, 1348.1 feet from the SE corner of the  $NE\frac{1}{4}$  of Section 21, T32N, R111W.
