



* OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming
May 8, 1970

The Board met, this date, in a special meeting with the Town Council of the Town of Pinedale in the Town Council chambers at 7:00 P.M., with Jake Pfisterer, chairman; Robert M. Miller, member; Paul C. Hagenstein, member; Elton Cooley, council member; Paul Hanson, council member; Bob Sweedler, council member; Bob Dew, council member; Jean Risser, Town Clerk and Robert W. Evans, County Clerk present.

The Board and Town Council discussed the boundary for zoning proposed around the town limits of Pinedale. It was agreed by the Town Council and the Board of County Commissioners that the town would zone the following lands:

Sections 33 and 34, of T34N, R109W.
Sections 33 and 4, of T33N, R109W.

The Town Council discussed the possibility of setting up an Airport Board and submitting a budget for county funds. The Board pointed out to the council that a budget must be prepared prior to June 1, 1970, if they were desirous of obtaining funds for the 1970-71 fiscal year.

The Council also discussed the possibility of getting a city dumpground adjacent to the industrial site for which the Board recently submitted an application to purchase from the Bureau of Land Management. It was explained to the Council that the Board of County Commissioners was in the process of obtaining various dumpgrounds throughout the county and presently have an application submitted for buying a dumpground at Daniel.
