

## OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming  
July 7, 1970

The Board met in regular session on this date, at 9:00 A.M., with Jake Pfisterer, chairman; Robert M. Miller, member; Paul C. Hagenstein, member; Elmer Falter, Road & Bridge Supt. and Robert W. Evans, County Clerk, present.

The minutes of the June 2, 1970, meeting were approved as read.

The monthly reports of the following County Officials were approved and ordered filed with the County Clerk: Hazel Bloom, Clerk of Court; Dolores Daniels, Justice of the Peace, Big Piney; Paul Ziegler, Justice of the Peace, Pinedale; Morris C. Horton, County Sheriff and Robert W. Evans, County Clerk.

Moved by Commissioner Miller, seconded by Commissioner Hagenstein, motion carried that the following appointments to the various boards be made:

Bud Jorgensen, five year term to the Hospital Board  
Phil Marincic, Jr., re-appointed to a five year term to the Fair Board.  
Virginia Pape, three year term to the Library Board.  
Robert Thompson, re-appointed to a three year term to the Museum Board.

Gary Carter, Motorola representative, met with the Board to discuss the completed county radio system. Motion by Commissioner Hagenstein, seconded by Commissioner Miller, motion carried that Motorola be paid for the radio system.

Bob McNeel and Harley Johnson met with the Board to discuss the status of the Upper Hoback River Road. These gentlemen indicated that they were unwilling to sign easements on the road if the road was to be used for logging trucks to bring logs from the recent timber sale of the Forest Service. Mr. McNeel requested that the Board contact the Teton Forest Service Office and ask the Forest Service what their intentions on the use of the road would be.

Earle Crandall met with the Board to discuss the possibility of obtaining a blanket easement for laying telephone cable in the county right-of-ways along county roads. The Board instructed Mr. Crandall to present the easement and to have stipulated, in the easement, that no cable would be laid in the county right-of-ways without first consultation with the Road & Bridge Supt.

Mayme Devine met with the Board to discuss the possibility of the county working on the Horse Creek Road. The Board informed Mrs. Devine that they intend to do some work on the Horse Creek Road this year.

Richard Hecox met with the Board to discuss the possibility of obtaining a public dumpground from the Forest Service in the Kendall area. It was pointed out to Mr. Hecox that the Board had discussed with the Forest Service, the possibility of buying a dumpground for the public's use in the Kendall area. The Forest Service was not receptive to the idea.

Rob Lozier and Lawrence McKenzie met with the Board to discuss the Boulder-North Road. The Board instructed John Mackey, Sublette County Attorney, to submit a letter to the Attorney-General requesting the Attorney-General's recommendation for a procedure for the county to follow in implementing Section 24-1, of the Wyoming 1957 compiled Statutes.

Mr. & Mrs. Otis Carney and Mr. & Mrs. John Buyer met with the Board in regards to the roads entering their ranches in the Kendall area. The Board informed these people that they were presently working on a road policy, for county roads, to be used in determining what roads would be taken into the county road system.

Dean Binning, Joella Dugan, Stan and Tom Murdock met with the Board to discuss the road petition submitted for the Dean Binning Road. Stan and Tom Murdock indicated that before they would sign an easement on the Dean Binning Road they wanted the county to do the following work on the Horse Creek Road:

1. Fix the water hole so the cattle could get to the water.
2. remove the old bridge.
3. Fix the approach to the old road so that it could be used to haul hay.
4. Smooth up the area.

Also the Following requirements were stipulations for an easement from the Murdock brothers, to the county, for the Dean Binning Road:

1. The borrow-pits would not be greater than a 3-1 slope.
2. Borrow-pits not to be over two foot deep.
3. That the county would be willing to insert pipe, across the roadway, for any future irrigation project.

The Board felt that they would be willing to accept a standard eighty foot easement.
