

## Official County Commissioners Proceedings, continued

Pinedale, Wyoming  
July 7, 1970

Kenneth Widstrand, Don Townsend and Mrs. Anna Townsend met with the Board to discuss the easements presented them, from the county, for a road right-of-way for the Paradise County Road. They requested that the county build fences along a portion of this road on the Anna Townsend and Kenneth Widstrand property. The Board informed the group that this was acceptable if, and when, the road became a county road.

Paul Scherbel, County Surveyor, met with the Board and presented the Board with a Plat of the Bondurant Cemetery and the County Road leading into the Bondurant Cemetery.

Dr. Bert Reinow met with the Board to discuss the Hospital Construction Committee's recommendation that a Bond Issue be submitted, to the voters, for the D & T Center at Big Piney and a D. & T Center with a Nursing Wing in Pinedale. The Board requested that the Hospital Construction Committee go ahead and do the necessary work in getting the Bond Issue on the ballot for the Primary Election to be held the 18th of August, 1970. The amount of the Bond Issue to be \$4650.000.00.
