Pinedale, Wyoming

Chairman Pfisterer reported to the Board that the Wyoming Highway Dept. had informed him that the bid on the re-surfacing of the Rye Grass, Fremont Lake and North-Piney Roads was higher than the estimate given by the engineers by approximately \$9,300.00. He also reported that the Highway Dept. advised that the Board of County Commissioners accept the bid at this time due to the fact that it might be some time before another bid would be let on these roads. The successful bidder for re-surfacing these roads was Gilpatrick Construction Company.

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming
July 27, 1970

The Board met in special session, this date at 8:00 P.M., in the County Commissioners room of the Sublette County Courthouse.

Chairman Pfisterer called the meeting to order and upon roll call the following were present: Chariman Jake Pfisterer, Commissioners Paul C. Hagenstein and Robert M. Miller and County Clerk, Robert W. Evans.

Thereupon Commissioner Pfisterer introduced the following resolution which was read in full and is as follows:

RESOLUTION

WHEREAS, the County Commissioners of Sublette County, Wyoming, deem it necessary and advisable for the County of Sublette, Wyoming, to construct and equip a diagnostic and treatment center in Big Piney, Wyoming, and a diagnostic and treatment center, together with a twelve-bed nursing home facility in Pinedale, Wyoming, and to submit to the qualified electors of the county the question of issuing general obligation bonds in the pricipal amount of \$465,000 for such purpose:

WHEREAS, if the question of issuing bonds for such purpose is approved by a majority of the qualified electors of the County voting thereon, then such authorization shall replace the authorization by the qualified electors at a special bond election on August 18, 1968, relatinf to the issuance of bonds in the amount of \$300,000; and

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SUBLINTE COUNTY, WYOMING:

Section 1. That at the primary election to be held in Sublette County, Wyoming, on Tuesday, the 18th day of August, 1970, there shall be submitted to the qualified electors of the County the question and proposition more particularly described in the Notice and Ballot hereinafter set forth.

Section 2. The election on the question of contracting bonded indebtedness of the County shall be held in the same districts and precincts, at the same polling places, and shall be conducted by the same Judges and Clerks as shall be designated for the primary election and the vote shall be canvassed and returned and the result declared in the manner prescribed by law for other county elections.

On the day of said election the polls shall be opened at 9:00 o'clock A.M. and they shall be kept open without and adjournment untill 7:00 o'clock P.M., at which time the polls shall be closed.
