Section 7. The Notice and Proclamation shall be signed by the Chairman and attested by the Clerk of the Board of County Commissioners and shall be in substantially the following form:

PROCLAMATION AND NOTICE OF SPECIAL BOND ELECTION
TO BE HELD IN SUBLINTE COUNTY, WYOMING,
ON THE 18TH DAY OF AUGUST, 1970

PUBLIC NOTICE IS HEREBY GIVEN That pursuant to the provisions of Title 18, Chapter 5, Article 3, Wyoming Statutes 1957, as amended, and Title 18, Chapter 9, Wyoming Statutes 1957, at the Primary election to be held in the several election districts and polling precincts in the County of Sublette, on Tuesday, the 18th day of August, 1970, there shall be submitted to the qualified electors of said County, the following question and proposition:

"Shall the County of Sublette, Wyoming, be authorized to issue general obligation Hospital Bonds of said County in the principal amount of \$465,000 bearing interest at a rate or rates not exceeding the maximum rate of 6% per annum allowed by statute, payable semi-annually, maturing serially within 20 years from their date, for the purpose of constructing and equipping a building for use as a diagnostic and treatment center in Big Piney, Wyoming, and a diagnostic and treatment center, together with a twelve-bed nursing home facility in Pinedale, Wyoming?"

The election on the above question shall be held at the same election districts, precincts and polling places as designated for the Primary Election to be held on the same day, and are as follows:

The polls shall be opened at 9:00 o'clock A.M. and shall be kept open without any adjournment until 7:00 o'clock P.M., at which time the polls shall be closed.

At each polling place there shall be provided two ballot boxes, one to be designated Ballot Box "A" and the other Ballot Box "B". There shall also be provided two sets of ballots, one of which shall be printed on white paper and the other on colored paper, both of which shall contain the same statement of the question to be voted upon and the same instructions concerning the manner of marking the ballot.

If such elector is not the owner of or the spouse of the owner of real or personal property assessed on the assessment roll of said County, he shall be furnished by the officers conducting said election a ballot printed on white paper and the ballots of such persons shall be deposited in Ballot Box "A". If such elector is the owner of or the spouse of the owner of real or personal property assessed on the assessment roll of said County he shall be furnished by such officers a ballot printed on colored paper and the ballots of all such persons shall be deposited in Ballot Box "B".

Every citizen of the United States of the age of 21 years and upwards who has resided in the State of Wyoming one year, in the County of Sublette sixty days and in the election Precinct wherein he seeks to vote ten days next preceding said election, and who has complied with the registration laws, shall be entitled to vote thereat, provided he appears in person at the polls on election day.
