OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming
October 12, 1970

The Board met in special session this date at 8:30 P.M., with Paul Hagenstein, member and Robert W. Evans, County Clerk.

Also present was Jim Vandel, Needs Engineer of the Wyoming Highway Dept. Mr. Vandel explained the reason for calling this meeting was to go over the proposed roads, in Sublette County, with the County County Commissioners. He also explained that in 1972 the Wyoming Interstate Road Program would be discontinued and at that time the Wyoming Highway Dept. was hopeful of coming up with a road plan such that the monies now held in reserve would not be spent for any purpose other than roads. Mr. Vandel explained that the roads in Sublette County had been classified into four groups: rural Principal arterials, rural minor arterials, rural major collectors and rural minor collectors. It was pointed out, by Mr. Vandel, that these roads would be studied and that the minimum specs would be written as to requirements for these roads. It was recommended by the Commissioners that nine additional roads be included in the minor collectors and that one road be deleted. Also that the Big Piney-Calpet Road be changed from a minor collector to a major collector. Mr. Vandel stated that a good portion of the Highway money had been spent for the interstate program and that in the future the Highway Dept. planned on spending more money on other roads.

There being no further business the meeting was adjourned at 10:00 P.M.
