OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming
December 1, 1970

The Board met in regular session, this date at 9:00 A.M., with Jake Pfisterer, Chariman; Paul C. Hagenstein, Member; Michael Marincic, Member; Elmer Falter, Road and Bridge Supt. and Robert W. Evans, County Clerk present.

The minutes of the November 5, 1970 meeting were approved as read.

On motion by Commissioner Hagenstein, seconded by Commissioner Pfisterer, motion carried that Michael Marincic be appointed to fulfill the unexpired term of Robert M. Miller as County Commissioner.

The monthly reports of the following County Officials were approved and ordered filed with the County Clerk: Hazel Bloom, Clerk of Court; Dolores Daniels, Justice of the Peace, Big Piney; Paul Ziegler, Justice of the Peace, Pinedale; Bud Slatter, County Sheriff and Robert W. Evans, County Clerk.

The following bonds were approved and ordered filed with the County Treasurer: Mildred Miller, Treasurer, Big Piney Cemetery District, one thousand dollars (\$1,000.); Ross L. Calvert, Treasurer Sublette County Fair Board, two thousand dollars (\$2,000.); and C. R. (Bud) Jorgensen, Treasurer, Sublette County Memorial Hospital Board, five thousand dollars (\$5,000.).

The following bond was approved and ordered filed with the County Clerk: Michael Marincic, Sublette County Commissioner, one thousand dollars (\$1,000.).

Dean Binning met with the Board to discuss the status of the Binning County Road. The Board pointed out to Mr. Binning that an error had been made in the legal description for the Murdock easement and that part of the land involved belonged to the Charles Buyer estate. It would therefore be necessary to correct the legal description for the easement and obtain an easement from the Charles Buyer estate.

Bud Slatter and Bob McFarland met with the Board and presented their findings on the renting of snow machines for the Sheriff's Department. Mr. Slatter stated that snow machines rent for \$6.00 an hour with a \$50.00 deposit. The Board then discussed with Mr. Slatter the possibility of buying a snow machine to be used by the Sublette County Sheriff's department. Bud Slatter said that Monte Wight would furnish a Ski-doo to be used by the Sheriff's office in Pinedale. The Board instructed Mr. Slatter to buy a Ski-doo, for the Big Piney area, to be used by the Sheriff's department.

Fred Kratz met with the Board to discuss the status of the proposed zone change, on his property, from A-1 to C-1. The Board informed Mr. Kratz that a hearing had not been set, by the County Commissioners, due to his failure to pay the required \$25.00 deposit to cover the publishing
