The Board reviewed the State Examiner's report on examination of Sublette County offices, Pinedale, Wyoming as of the close of business, September 30, 1970, and replied as follows:

TREASURER:

1. Funds received by the County Treasurer's office, where received from apparty redeeming property sold at tax sale will be recorded as a receipt and a disbursement will be recorded as a disbursement in the office.
2. Concerning advance of funds; the constitutional provisions as set forth in Article 16-6 will be observed.
3. Securities pledged to the county and covered by Trust Receipts will not be hereafter released until replacement securities are on hand and in this office.
4. Apparently the examiners overlooked a committment from the State Bank of Big Piney, dated February 28, 1970, whereby the bank offered the standard F. D. I. C. insurance of \$20.000.00 plus \$400.000.00 par value of securities in accordance with an attached schedule which should satisfy the requirement of the examiner.

CLERK:

1. The sum of \$3,85 has been adjusted to the satisfaction of the County Clerk.
2. The system of cash orders will be eliminated without further delay.

SHERIFF:

1. The sum of \$4.00 will be remitted to the Fremont County Sheriff as indicated.

JUSTICES OF THE PEACE:

1. Dolores Daniels will not remit, to the County Treasurer, Sheriff's fees for service of papers. The Sheriff will henceforth be instructed to retain fees for the service of papers.

COMMISSIONERS:

1. Speedometer readings will be used in those instances when distandes cannot be verified by the official state highway map, and all concerned personnel will be properly notified.
2. The County Retirement Program will be continued until advised to the contrary by the office of the Attorney General for the State of Wyoming.
3. The observations set forth in paragraph three are duly noted.
4. The County Treasurer will be instructed to reduce the General Account by the sum of \$15,840.00 and to raise the Depreciation Reserve Account from a negative \$15,840.00 to a zero balance and this will be accomplished on the date hereof.

The Board met with Ethelyne Worl and Betty Blake with respect to easements for the Pinedale-East Road. Betty Blake refused to give an easement on her property for this road.
