And terminating at a point S54°-18'W, a distance of 2377.3 feet from the NE corner of Section 24, T32N, R108W.





WHEREAS, there are no federally owned lands.


NOW, THEREFORE, BE IT RESOLVED, that the Steele Lane County Road No. 23-155, as described above, be and it hereby is declared established as a public road.
