



## OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming  
May 5, 1971

The Board met on this date with all members present.

Miss Virginia Baldwin, Dist. #4 Supervisor, Mrs. Carol Leslie, Mrs. Nancy Anspach met with the County Commissioners. Names were suggested for the Public Health Nurse Advisory Committee and a tentative date of June 30th, at 2:00 P.M., was set for this Board meeting. The Commissioners will personally contact the individuals suggested for this Board. The Pinedale Clinic was graciously shown to the County Commissioners, County Clerk, Miss Baldwin, Mrs. Leslie, and Mrs. Anspach by Dr. J. Thomas Johnston. Available space was deemed adequate and furniture, fixtures etc, were discussed and they will be located.

County Commissioners, Mr Ed Giebel and Paul Scherbel viewed the Cora Lane Road, the Industrial Site, Cora Dumpground and Cora Historical Cemetery site, the Daniel Dumpground and Perry Binning zone change area.

Back to the office by 5:00 P.M. with Mr. Paul Scherbel. The Pole Creek Driveway; Ehman Lane Road curve under extensive discussion. Upon motion of Michael Marincic, seconded by Jake Pfisterer, the Ehman Lane Road, No.23-144, formerly resolved as Cora Lane Connection Road in Commissioners Record, Book 2 on Page 79, be and is now resolved a County Road.

RESOLUTION

WHEREAS, the Board of County Commissioners of Sublette County, Wyoming, deem the public interest requires that a road be established known as the EHMAN LANE COUNTY ROAD No.23-144, originally known as the Cora Lane Connection Road as resolved in Commissioners Record, Book Number Two(2) on Page 79, dated March 13, 1962, described as follows:
