Pinedale, Wyoming
October 5, 1971

The Board met in regular session on this date with all members present. The minutes of the previous meeting were approved as read.

The monthly reports of the following officials were approved and ordered filed in the County Clerk's Office. Hazel P. Bloom, Clerk of Court; Aune R. Clark, County Clerk; Robert McFarland, Sheriff; Kathryn Orr, Justice of Peace, Big Piney; Paul Ziegler, Justice of Peace, Pinedale.

The following bonds were approved: Robert Ray Robertson, Southwest School District No. 9, Big Piney, Wyoming, in the amount of \$5,000.00 as Superintendent. Lloyd C. Alexander, in the amount of \$1,000.00 as Treasurer for Pinedale Airport. Jean B. Risser, in the amount of \$2,000.00 as Clerk Treasurer for the Town of Pinedale.

The Petition for Abatement of Taxes, By Ray Wardell, School District #9, \$1,000.00 valuation, was reviewed and Reduction Tax Order #245 was issued and filed in the County Treasurer's Office for \$48.87.
