RESOLUTION

WHEREAS, The Board of County Commissioners of Sublette County, Wyoming, deem the public interest requires that a road be established to be known as the Muddy Creek County Road No.23-177 described as follows:

Commencing at station 0+00 on the East right-of-way line of U.S. Highway 189, N87°-00'W, 2545.8 feet from the SE corner of Section 33, T.31N., R111W.

Thence running easterly through the following:

T31N, R111W., 6th P.M.  
Section 33 - S $\frac{1}{2}$ SE $\frac{1}{4}$   
Section 34 - SW $\frac{1}{4}$ SW $\frac{1}{4}$

Thence running northerly through the following:

T31N, R111W., 6th P.M.  
Section 34 - W $\frac{1}{2}$ W $\frac{1}{4}$   
Section 27 - W $\frac{1}{2}$ SW $\frac{1}{4}$ , NE $\frac{1}{4}$ SW $\frac{1}{4}$ , E $\frac{1}{2}$ NW $\frac{1}{4}$

Thence westerly through the following:

T31N, R111W., 6th P.M.  
Section 22 - S $\frac{1}{2}$ SW $\frac{1}{4}$   
Section 21 - S $\frac{1}{2}$ SE $\frac{1}{4}$

And terminating at station 0+00 on the East right-of-way line of U.S. Highway 189, N57°-20'W, 2481.6 feet from the SE corner of Section 21, T31N, R111W, 6th P.M.
