THENCE northerly through the SE $\frac{1}{4}$ NE $\frac{1}{4}$  of said Section 20 to a point of ending N63°-35'W, 513.7 feet from the east one-quarter corner of said Section 20, T35N, R110W.

WHEREAS, right-of-way easements have been secured from Carroll R. Noble, State of Wyoming, Reservoir Ranch Company, and Bar Cross Land and Livestock as owners of the only patented lands.


WHEREAS, an affidavit for Right-of-Way has been filed and granted by the Land Office in Cheyenne, for all Federally owned lands.




