Board met in special session on this date with Jake Pfisterer and Chairman Paul Hagenstein present, and Aune R. Clark, County Clerk.

James Miller, Carroll James, Bill Alexander, Robert Coleman Corp of Engineers, Sacramento District, Mr. McGregor, Corp of Engineers, Sacramento District, out of Salt Lake City, Utah and Glen Dunning.

A discussion on flood prevention work needed on the Green River near Daniel, Wyoming to contain the Green River in its banks when snowmelt flood water raises the water level.

By mutual consent culverts for ditches and ditch crossings would be obtained by the County Commissioners, but paid for by land or ditch owners, as quickly as possible or sooner. Rights of entry were signed by the land owners present and by Jake Pfisterer Motion, second by Paul Hagenstein the following resolution to adopt an Assurance Agreement was unanimously passed.

Resolution

WHEREAS, The Board of County Commissioners, Sublette County, Wyoming, deem it necessary to construct emergency levees for the protection of the town of Daniel, Wyoming and surrounding rural areas, which are threatened by snowmelt run off flood waters.

WHEREAS, The Board of County Commissioners had contacted the Army Corp of Engineers for assistance in the spring of 1971, at which time the Corp inspected the area and promised to help in 1972.

WHEREAS, The Board of County Commissioners have obtained Right of Entry from W. D. Alexander, for Section 27, T34N., R111; Carroll James, Section 28, T34N., R111, and James M. Miller for Sections 27, 29 and 35 T35N., R111.

- NOW THEREFORE, The Board of County Commissioners so hereby give assurance that it will:
- a. Furnish borrow areas necessary for the work.
 - b. Provide right of ingress and egress from existing public road to site of work and borrow areas.
 - c. Hold United States of America whole harmless from any or all damages due to work performed.
