

Official County Commissioners Proceedings, Continued

June 6, 1972

Red Wilkerson and Bob Tracey were in to discuss the Solid Waste problems, and it was agreed that a meeting would be held, at everyone's convenience to come to some understanding of this problem.

The Oil and Gas Bids, Diesel Fuel, and Tire Bids were opened and read aloud. Delgado Oil Company, being the only bidder, they were granted all the gas and diesel fuel, and some of the tire bid by Jake Pfisterer motion and second by Michael Marincic. and carried.

On presentation of the Mineral Springs Subdivision Plat, by Gooch and Stockton, Jake Pfisterer moved we accept the subdivision plat with a suggested 50' to 100' right of way across East Fork River. Seconded by Michael Marincic, motion carried. County will contact the Bureau of Land Management for right-of-way in Section 8, T.32N., R107W.

Mrs. Bernie Gosar was asking about balloting the Wagon Wheel Project question at the Primary or General Election. Mr. Paul Hagenstein suggested they handle this question by way of a straw vote at one of the elections, or by mail.

Ben Pearson, Pat Pearson, and Lillian C. Allen asked the official status of Road No. 33 originally established in 1907. After much discussion an agreement for further research on the old records might establish this road status.

Daniel-Merna Road #23-112 came under much discussion with Stanley Murdock. With an agreement that a 65' right of-way, taking 30' on the South and 35' on the North side of the road below Delbert Balls TurnOff. Jake Pfisterer moved we would accept and Michael Marincic seconded. Stan Murdock said he would sign the right-of-way.

Two recommendations from the Planning and Zoning Commission was brought in by Bob Evans. 1. Application of the Boulder Lake Ranch for Zone Change on 160 acres from RC Zone to SR-1 zone with Covenants and Deed restrictions be recorded on this property, and that roads within subdivision be retained as private roads, the Commission then recommends the zone change. By Michael Marincic motion and Jake Pfisterer second the County Clerk was instructed to publish the Public hearing to be held on July 7th at 8:00 o'clock P.M.

A variance be approved and granted to Carl Winter on approximately two acres of land South of Pinedale to build a three bedroom home and install a State Approved Sewer System.

Albert Nelson brought in the Barger 111 Subdivision preliminary plat for review.

Bob Harrower brought in the Bayers Riverside Subdivision for review, and what needed to be done for zoning classifications and roads.

Earl Young asked about having a County Road made out of the road by Tyler Subdivision, and was given a Petition for this road and further instructions.
