## RESOLUTION

WHEREAS, The Board of County Commissioners of Sublette County, Wyoming, deem the public interest requires that a road be established to be known as the Boulder North County Road No. 23-104, described as follows:

Beginning at 0+00- S89°33' E on the south quarter corner of Section 10, T.32N., R.108W. 6th P.M.

Thence North to station N00°-01W 39.42.1' then north 39+42.1 to the west quarter corner of said section 10 T.32N., R.108W.

Thence northeasterly thru the NE $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 9, T.32N., R.108W to station 53+57.70 and

Thence, north westerly thru the East half of Section 4 to station 105.67.10 - N 40-37'E 13.30';

Thence, east to station 112+57.20', N79°-01'E 74.2'
