OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

August 10, 1972
Pinedale, Wyoming

The Board met in Special Session on this date with all members present.

The proposed New Fork Lake Industrial road was discussed with Mel Holt, District Ranger and Mr. Noblett of the Forest Service, Mr. DeBernardi, and Mr. Hilton of the State Highway Commission and the County Commissioners. No conclusive action was taken, but the Highway Department will conduct a tour and survey this road.

Bid on 42 windows and one entrance way door for the County Courthouse, having been duly advertised, with two bids received, one from Highland Company, Inc., and one from Calson and Wenz Construction.

Both bids were opened and publicly read aloud and considered. By a Michael Marincic motion, we grant the Carlson and Wenz Construction the bid for the 42 windows and one entrance way door for the Courthouse at the bid price of \$8,252.67. Bid to the specifications advertised. Second by Jake Pfisterer and motion carried. Highland Company, Inc. bid was for \$8,653.00.
