





OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

December 19, 1972

Pinedale, Wyoming

The Board met in Special Session on this date with Paul C. Hagenstein and Michael Marincic at 1:45 P.M.

Mr. Thomas B. Muths of Design Associates of Jackson, Wyoming discussed the Jail and its facilities, and what to do to improve these facilities with the Commissioners and Bob McFarland. Mr. Muths would take all of the suggestion under advisement and try to get a plan together for the Governor's Planning Committee to study.

The Public Hearing, having been duly advertised, was held at 7:00 o'clock P.M. in the Court Room with all members present and the following interested individuals. Mr. Riddle, Billy Dockham, George Osselton, Mr. Scores and the County Commissioners and W.E. Clark, Zoning Adminstrator and the County Clerk.

1. Planning and Zoning Commission request to amend the zoning Map of Sublette County Resolution by changing the zoning classification from Agricultural to Rural Residential on a tract of Land containing 80 acres located approximately in SW $\frac{1}{4}$ NE $\frac{1}{4}$ & SE $\frac{1}{4}$ Sec. 23, and, NW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 26 T.37N., R. 113W. 6th P.M.

Mr. Billy Dockham gave letters and verbal testimony from land owners within this area that did not believe this Zone change classification was feasible and definitely not desired by them.
