OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming
April 3, 1973

The Board met in regular session on this date with all members present. The minutes of the previous meeting were read and approved as read.

The monthly reports of the following Officials were approved and ordered filed in the County Clerk's Office. Hazel P. Bloom, Clerk of Court, Aune R. Clark, County Clerk, Robert L. McFarland, Sheriff, Paul Ziegler, Justice of Peace.

The following Acceptance Agreements were approved and monies ordered deposited in the County Treasury: No. 684, State of Wyoming \$20.00; No. 685, Surveyor Scherbel LTD., \$25.00.

Dr. J. Thomas Johnston presented the County Commissioners the proposed Subdivision Resolution that the Subdivision Resolution committee has been working on. Dr. Johnston stated that this is a rough draft of what the Committee would like to see adopted, but they were open for suggestions and changes. This Subdivision resolution is composed of the Sublette County proposed Subdivision Resolution as a foremat, the County of Teton's plan, and the States of California, New York and Colorado. Copies have been mailed to all members of the Subdivision Committee, and the County Commissioners will study this plan and set up the necessary meetings, at a later date.

Robert Seaton, Agricultural Agent was in to tell the Commissioners that the Sewer at the Extension Office is probably broken or caved in and as soon as the ground is thawed, probably will have to be replaced. The County Commissioners stated that it would have to be fixed. The new Weed and Pest Control District was discussed, and Mr. Seaton agreed to distribute petitions for the appointments of directors.

Robert McFarland presented a letter received from the LETS System, by his office, that legislature failed to approve money for the LETS System, therefore the terminal users will have to assume the increase for the use of the Teletype machines. Discussion was held on the ways of obtaining the money necessary for this project. Perhaps prorate the cost thru the various users. Jake Pfisterer moved we find out if all counties will be paying the entire amount and if so, we would go along to raise money for the teletype system. Paul Hagenstein seconded and motion carried.

Mr. McFarland also presented the County Commissioners with a tentative agreement that stated that the requesting parties for Rescue work will be responsible for the fees incurred in Helicopter rescue and such other unforeseen expenses necessary for difficult rescues. The Commissioners suggested he contact the County Attorney on the legality of this type of form.

William Faris came in to discuss the Dell Creek Road 23-113. He could not tell where the road went thru his property and wondered if it was the old road. Also mentioned Section Corners and Quarter corners that he knew about. The Commissioners stated that as soon as the weather cleared up and these corners could be found, the Commissioners and a surveyor would visit with Mr. Faris and permanently establish the corners he knew about.

Mr. Griggs from Lincoln Service Company came in to request a plat of the Industrial Site and was informed that such a plat was not filed, as yet.

John Teichert, District 4 Water Commissioner came in to discuss a part time Water Commissioner, if needed, salaries, etc., Nothing definite was settled.

Bill Dockham and Mr. Pearson, were in to see if any decision would be made on Mr. Brocking's Zone Change. The Commissioners still have it under advisement and will let interested parties know, when the decision will be made.
