OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming  
April 12, 1973

The Board met in Special Session on this date at 6:30 P.M. with all members present. Mr. Mike Noble, Mr. Jim Noble, Milford Steele, and Marlin Wright of the State Highway Department were also present.

A discussion on the New Fork Lake Road was held with Paul Hagenstein, Commissioner, informing the group that matching funds would be withdrawn as of July 1, if something definite was not started on said road, such as a better route for it. Jim Noble wanted to know what better route there was than the one that was reviewed last fall with the Forest Service. Bridging the Creek at the spot picked out last fall because of rock and leveling the ground made the route too expensive. Jim Noble stated he could not see the necessity of two roads in the area, he was sure the summer homes in that area would need a road to get to and from their homes. The approach off of the Cora North Road was also discussed and new approaches questioned. Jim Noble suggested that perhaps we should get a hold of the Forest Service and if a cost estimate has not been given on the road as proposed last fall, let the money go by. We don't need two roads in that area. Mr. Mike Noble agreed. On general agreement Mr. Marlin Wright and the Commissioners will contact the Forest Service for Cost Estimates, etc. so something could be started before the July 1, 1973 dead line. Milford Steele gave his explanation on the Petitions which he helped to get circulated and then filed in the County Clerk's Office for Directors for the New Weed and Pest Control Board.

County Attorney John S. Mackey and the County Commissioners discussed and considered ways and means of obtaining a right-of-way from Bill Bloom and John Dussault. Mr. Mackey was given instructions to call Mr. Bloom up and get his views on the right-of-way.
