1. Kaumo Petition requestion zone change for 60 acres from A-1 to RR-1, after much discussion Jake Pfisterer moved we rezone the full 60 acres of land from A-1 to RR-1, Paul Hagenstein seconded and motion carried unanimously.
2. Burleigh Binning application for zone change of 620 acres. Mike Marincic recommended we delay this change until we go thru our subdivision resolution. Jake Pfisterer wanted the restrictions and covenants to include the Planning and Zoning request incorporated and to be drawn up ready for recording. Bill Clark wanted a better draft of the acreage so he would know where Jack Richardson's 40 acre tract was and if it was included in the zone change and if the restrictions and covenants would apply to him. Paul Hagenstein, moved we withhold decision for further study. Jake seconded and motion carried. Also suggest that Bill Clark write a letter to Joe Tynsky Public Health Engineer for a study of the seepage water on Jim Noble's Hill.

Paul Hagenstein made motion to change Seasonal Residential to Recreation Residential in the Zoning Resolution, Jake seconded and motion carried.

Jake Pfisterer moved we amend zoning resolution by incorporating word change to Article II Section 9b to include compliance with the water well minimum construction standards as issued by the State Engineer's Office, for the State of Wyoming. Paul Hagenstein seconded and motion carried.

There being no further business Paul Hagenstein moved we adjourn at 9:30 P.M.
