OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

July 10, 1973
Pinedale, Wyoming

The Board met in regular session on this date with all members present: The Board met at 9:00 o'clock A.M..

Mr. Glen Sugano from the State Highway Department at Rock Springs, Wyoming, discussed road approaches to the State Highway, with the County Commissioners. After some discussion, Mr. Sugano would inform the County as to the State's position.

Wayne Anderson of the Bridger-Teton National Forest presented a Cooperative Agreement to the Board for their consideration. After a discussion period the agreement was signed and accepted on a Jake Pfisterer motion and a Paul Hagenstein seconded and carried.

Bob Harrower, Bob Sievers and Joe Hicks presented the Redstone Corporation Plats, and discussed road-right-of-ways and bridges. Paul Hagenstein moved we accept the Redstone Corporation Plats, Jake seconded and it carried.

Bartley Skinner presented the Commissioners a Road Petition for a County Road, duly signed by ten or more electors of the county residing within fifteen miles of the road. The road commences at NW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 4, T.33N., R. 108W., 6th P.M. and running thence Easterly across NE $\frac{1}{4}$ NW $\frac{1}{4}$, N $\frac{1}{2}$ SE $\frac{1}{4}$, Section 4, SW $\frac{1}{4}$ N $\frac{1}{2}$ SE $\frac{1}{4}$ Section 3; N $\frac{1}{2}$ SW $\frac{1}{4}$, N $\frac{1}{2}$ SE $\frac{1}{4}$ Section 2 connection to the Meadow Lake Road in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 2 all in T.13N., R. 108W. 6th P.M. and terminating at Meadow Lake Road. Paul Hagenstein made motion we accept road petition and appoint a Road Viewer, Jake Seconded and motion carried.

Don Townsend, Mrs. Anna Townsend wanted to know what would be done on the Paradise Road and when. The County Commissioners set a Field Trip with these people and others on the Paradise Road for 4:00 P.M. July 16th.

With the completion of the Five Mile Bridge Jake moved we accept the bridge as completed and notify the State Highway Commission of same. Paul seconded and motion carried.

Donald Jewett and Donnie Noble discussed the need of a bridge in the Soap Hole on a County Road. Commissioners will take under advisement.

John Tiechert, John Brown and A. A. Thompson discussed the need for an assistant water commissioner to help A. A. Thompson. Commissioners agreed to pay John Brown July wages with the State paying his wages for the rest of the time.
