To a point of ending, which point bears N. 6° 11' E. a distance of 3699.4 feet from a point which bears N. 25° 28' E. a distance of 251.5 feet from a point on the south boundary of Section 35, T. 37 N., R. 110 W. from which the South $\frac{1}{4}$ corner thereof bears N. 88° 54' E. a distance of 116.3 feet

NOW, THEREFORE, BE IT RESOLVED, that the said Board do hereby initiate the procedure for the establishment of said road, and declare their intention to establish said road by following out the provisions of Section 24-43, Wyoming Statutes, 1957, not inconsistent therewith.
