Board met in Regular Session on this date with all members present. The minutes of the previous meetings were read and approved as read.

The Following Bonds were approved and ordered filed; Robert Ray Robertson, Superintendent School District No. 9, \$5,000.00; George LeRoy Snow, \$1,000.00, Deputy Sheriff; Patric C. Mattimoe, \$5,000.00, Treasurer-Pinedale Volunteer Fire Department.

The following Acceptance Agreements were approved and money ordered filed in The County Treasury: No. 716: Sublette County Sporting Ass'n, Malt Beverage Permit \$10.00; No. 717: TBC Land & Recreation Development Corp.
